Highlights of the Findings of the U.S. Global Change Research Program's Climate Science Special Report

November 3, 2017 U.S. Global Change Research Program's (USGCRP) Climate Science Special Report (CSSR), which serves as Volume I of the Fourth National Climate Assessment, describes current trends in the climate globally and for the U.S., and projects trends in temperature, precipitation, sea-level rise, and Arctic sea ice for the remainder of this century.

Findings include:

- Global and U.S. temperatures continue to rise
- The annual average temperature for the globe and the contiguous U.S. has increased 1.8 degrees °F from 1901 to 2016.
- Sixteen of the warmest years on record for the globe occurred in the last 17 years; the last three years were the warmest.
- Variability in temperature and precipitation is increasing.
- Heavy precipitation has increased in intensity and frequency across most parts of the U.S. since 1901, though there are important regional differences.
- Heatwaves have become more frequent in the U.S. since the 1960s.
- Cold temperatures and cold waves have decreased since the early 1900s.
- Annual trends toward earlier Spring snowmelt and reduced snowpack are already affecting water resources in the western U.S.
 - Ocean temperatures are warming.
- Global average sea level has risen by about 7-8 inches since 1900.
- Global average sea level is expected to rise by several inches in the next 15 years.
- Temperature increases in Alaska and across the Arctic are greater than the rest of the globe.
- Annual average, near-surface air temperature in Alaska and across the Arctic has in-

creased over the last 50 years at a rate more than twice as fast as the global average temperature.

• Since the early 1980s, Arctic sea ice extent has decreased between 3.5 percent and 4.1 percent per decade, has become thinner by between 4.3 and 7.5 feet, and on average the season of melting lasts 15 more days per year.

BACKGROUND

In June 2013, President Obama launched a comprehensive Climate Action Plan for the U.S. Government to cut carbon pollution, provide climate preparedness tools and information, and lead international efforts to address climate change. The Plan invokes the critical role of US-GCRP in developing sound science to manage climate change impacts.

Since 1990, USGCRP has been advancing Earth system science and growing the knowledge base needed to respond to a changing climate and a transforming world.

Report development was overseen by the Subcommittee on Global Change Research (SGCR) through a Federal Science Steering Committee (SSC), made up of representatives from USGCRP agencies and appointed by the SGCR. NOAA (National Oceanic and Atmospheric Administration) serves as the administrative agency for CSSR (i.e., NOAA established the procedures for the report and released Federal Register Notices).

The SSC selected three Coordinating Lead Authors, all of whom were Federal employees ,during the development of this report. Following a public call (via Federal Register Notice) for technical contributor nominations in March 2016, the SSC endorsed writing team selections, consisting of scientists representing Federal agencies, national laboratories, universities, and the private sector.

Contributing Authors were selected based on specific needs identified by the authors. Review Editors were chosen from the technical contributor pool and endorsed by SSC to ensure

Fair Use Law: http://copyright.gov/fair-use/

Fair use is a legal doctrine that promotes freedom of expression by permitting the unlicensed use of copyright-protected works in certain circumstances. Section 107 of the Copyright Act provides the statutory framework for determining whether something is a fair use and identifies certain types of uses such as criticism, comment, news reporting, teaching, scholarship, and research—as examples of activities that may qualify as fair use. Section 107 calls for consideration of the following four factors in evaluating a question of fair use:

(1) Purpose and character of the use, including whether the use is of a commercial nature or is for nonprofit educational purposes: Courts look at how the party claiming fair use is using the copyrighted work and are more likely to find that nonprofit educational and noncommercial uses are fair. This does not mean, however, that all nonprofit education and noncommercial uses are fair and all

commercial uses are not fair; instead, courts will balance the purpose and character of the use against the other factors below. Additionally, "transformative" uses are more likely to be considered fair. Transformative uses are those that add something new, with a further purpose or different character, and do not substitute for the original use of the work.


- (2) Nature of the copyrighted work: This factor analyzes the degree to which the work that was used relates to copyright's purpose of encouraging creative expression....
- (3) Amount and substantiality of the portion used in relation to the copyrighted work as a whole: Under this factor, courts look at both the quantity and quality of the copyrighted material that was used. If the use includes a large portion of the copyrighted work, fair use is less likely to be found; if the use employs only a small amount of copyrighted material, fair use is more likely. . . .
 - (4) Effect of the use upon the poten-

tial market for or value of the copyrighted work: Here, courts review whether, and to what extent, the unlicensed use harms the existing or future market for the copyright owner's original work. In assessing this factor, courts consider whether the use is hurting the current market for the original work (for example, by displacing sales of the original) and/or whether the use could cause substantial harm if it were to become widespread. . . .

that authors adequately responded to all comments received during the public and National Academy of Sciences, Engineering, and Medicine review periods.

Planning for the report began in early 2015 with a prospectus developed in the Summer of that year. That was followed by the development of process guidance and the naming of author teams. Writing began in April 2016 and an initial draft was made available for public comment in December 2016. A series of technical expert reviews were conducted throughout the report's development. SGCR was responsible for its final clearance and ultimately its public release.

Below are a few quotes from *The* (Manchester) *Guardian*'s article, "U.S. Report Finds Climae Change 90% Manmade, Contradicting Trump Officials."

"A lot of what we've been learning over the last four years suggests the possibility that things may have been more serious than we think,' said Robert Kopp of Rutgers University, one of the dozens of scientists inside and outside the government who wrote the studies."

"Despite fears by some scientists and environmental advocates, David Fahey of the National Oceanic and Atmospheric Administration (NOAA) and several authors said there was no political interference or censoring. It is the most comprehensive summary of climate science since 2013, showing a warming, worsening world."

"This period is now the warmest in the history

of modern civilization, said Katharine Hayhoe, co-author of Texas Tech. For the first time, scientists highlighted a dozen 'tipping points' of potential dangers that could happen from warming, things that she said 'keep me up at night."

"They [tipping points] include the slowing down of the giant Atlantic Ocean circulation system that could dramatically warp weather worldwide, much stronger El Niños, major decreases in ice sheets in Greenland and Antarctica, which would spike sea level rise, and massive release of methane and carbon dioxide from thawing permafrost that could turbo-charge warming."

Climate Change—A Summary and Invitation to Action

In 1982, moved by a book on nuclear war, I left my job at the Housing Department in Baltimore, sold my house, and began to work full-time to reduce the hostility between the United States and the Soviet Union.

In 2006 I read my first book on Climate Change, was appalled, and decided to shift my efforts to Climate Change. We're working now with universities, churches, labor unions, and social justice organizations.

On the basis of what I know now, here is a very brief summary of the Climate Change situation today.

Three human activities are responsible for man-made Climate Change: 1) the burning of fossil fuels—coal, oil, and natural gas; 2) deforestation, and 3) certain agricultural practices. All of these are ongoing, and, as a result, we are now seeing ever-intensifying consequences: Category 5 hurricanes, extreme tornadoes, rising oceans, floods, dying coral reefs, acidic oceans killing the base of the marine food chain, extreme heat, famine, drought, wildfires, rivers drying up, mass migrations, diseases, wars, and melting glaciers and ice caps.

These conditions are constantly intensifying and moving inexorably toward extreme states. How close they will come to those extreme states in the coming decades depends on us. Even now, these are very

harmful to humanity and nature, and are only going to get worse quite soon—because time is running out.

We have ignored the warnings of the world's climate scientists and we now face the imminent prospect of the abovementioned conditions entering into a self-propelled state which is irreversible, in the sense that our efforts to halt further change will become impotent. Scientists call the point at which we enter into this irreversible state a "tipping point." All that we will be able to do is watch and hope that the extreme states of those conditions will not, in the coming decades and centuries, eradicate all of life.

According to many climate scientists, one tipping point has already occurred—the melting of the West Antarctic ice sheet. And some others are likely to occur in 10 years!

The strong opposition to the actions needed to avert these consequences comes from 1) energy companies which reap obscene profits from the sale of fossil fuels and 2) most people who enjoy the lifestyle made possible by burning fossil fuels.

The only hope lies in enabling enough caring people to gain control of the federal government and bringing it to undertake a crash program, similar in magnitude to that during World War II. Such a program would be aimed at radically intensifying conservation of energy and the use of renewable sources of energy. Easy to say but

very difficult to do.

This is the current focus of the Grass-roots Coalition and it comes under the heading of 'systemic change' or non-violent revolution, and requires the involvement of many millions of Americans. To find the (wo)manpower needed for this we are looking to five sectors of society: 1) universities, 2) labor unions, 3) churches, 4) social justice organizations, and 5) currently inactive Americans. These five constitute a majority of the population.

Michael Mann, distinguished professor of atmospheric science and the director of the Earth System Science Center at Penn State University: "Whether we're talking about unprecedented heat waves, increasingly destructive hurricanes, epic drought, and inundation of our coastal cities, the impacts of Climate Change are no longer subtle. They are upon us. That's the consensus of our best scientists."

Canadian Warriors Remove Anti-Salmon Spawning Nets

SWIFT CREEK, Unceded, Unsurrendered Secwepemc Territory—Wild Salmon Warriors returned home yesterday after conducting a two-week observation and removal of Kinder Morgan's anti-salmon spawning mat that illegally disrupted four water ways in Secwepemc Territory.

The mats were installed without any knowledge or consent of the Nation, just as the Kinder Morgan pipeline is continuing without the free, prior, and informed consent of the Nation as well.

Upon learning the exact locations of four of the supposed seven installation sites, Wild Salmon Warriors, on the authority of the Secwepemc Nation, have removed all such mats in the area.

The Women of Nations across the pipeline route have been clear, they do not consent to Kinder Morgan or Justin Trudeau's dirty oil pipeline.

The warriors have been clear as well. This pipeline will not be built.


Dear Ella,





Mementos of a Retreat to the Ocean



After losing my job, my soul needed a trip to the ocean, so we planned three glorious days in the Rehobeth/Lewes area in Delaware, our favorite place to go.

I was thrilled to see the activist sign above giving residents and passers-by a direct phone number to call if chicken plant odors were bothering them. When I was an air pollution inspector in New Jersey long ago, there was a law that factories could stink up their own property but they were not allowed to stink up anyone else's. I loved that law and was able to enforce it then. I wrote 90 violations in 11 months for various infractions, and that was one of them.

I didn't get to the beach in Delaware in time to see the sun rise, so I'm substituting this picture to give you an idea of why it was important for me to get to the ocean. We defend marine species and habitat from overfishing, offshore oil drilling, the impacts of climate change, ocean acidification, and a host of other threats—from the Sea of Cortez to the Gulf of Mexico and the Atlantic, the Hawaiian archipelago to Japan, and Antarctica north to the Arctic Circle.

ABOUT OUR OCEANS WORK

Ocean waters cover three-quarters of the globe and are vast, mostly undiscovered havens for mysterious and diverse life. But the open oceans are also a free-for-all, barely regulated or policed. International laws to protect them are drastically inadequate to address threats like large-scale commercial fishing, which sweeps life out of the seas at unprecedented rates—often only to discard the unusable "bycatch." Tragically, that discarded bycatch includes thousands of severely injured or slain sea turtles, seabirds, and marine mammals annually. Meanwhile the oceans are rising, warming, and becoming more acidic because of our overreliance on fossil fuels. We're working to tackle some of the biggest threats with strategic campaigns.

- Scientific analysis
- Petitions and litigation to list species

under federal law

- Litigation to establish critical habitat for species
- Fishing policy reform through advocacy and litigation
- Strategic litigation to protect habitat
- Communications and media outreach

MILESTONES

The Center's Oceans program:

- Shut down the most destructive fisheries in the Pacific for endangered species—among others, the set-gillnet fishery off central California, including Monterey Bay, which drowned sea otters, harbor porpoises, elephant seals, sea lions, and seabirds; the California-based swordfish longline fishery, which killed leatherback and loggerhead sea turtles; and a lobster fishery that was starving Hawaiian monk seals.
- Achieved Endangered Species Act protections for the southern resident killer whale, Southwest Alaska sea otter, Cook Inlet beluga whale, bearded seal, 22 species of corals, white abalone, and black abalone.
- Secured critical habitat protection of 120 million acres for polar bears; 685 miles of beaches and more than 300,000 square miles of ocean for loggerhead sea turtles; 7,000 square miles in Hawaii for Hawaiian monk seals; 2,500 square miles around Washington's Puget Sound for southern resident killer whales; and 36,000 square miles of the Bering Sea for the world's most endangered whales, North Pacific right whales.
- Filed a lawsuit against the federal government resulting in a moratorium on fracking off the California coast, as well as a suit helping force the disclosure of the environmental impacts of offshore fracking—meanwhile organizing grassroots resistance against dirty fossil fuel development in Southern California.
 - Helped to build momentum for Presi-

dent Obama's decision to permanently protect large swaths of the Arctic and Atlantic Oceans from offshore oil and gas leasing by opposing all new federal offshore oil and gas leases through a variety of tactics from direct-action protests to fierce legal advocacy.

- Filed a groundbreaking petition that required the EPA to address carbon dioxide impacts on the ocean under the Clean Water Act. Carbon dioxide is making ocean water acidic, posing huge threats to marine species and the ocean web of life.
- Successfully sued the U.S. Navy over its indiscriminate use of sonar and explosions in the Pacific Ocean that were injuring whales and other marine mammals, forcing the military to develop new studies and plans to govern future operations.
