# Endangered Species Act Works: Marine Mammals and Turtles Bouncing Back

The Endangered Species Act works. That's the conclusion of a peer-reviewed study undertaken by scientists at the Center for Biological Diversity and published in PLOS ONE January 16th. The study looked at 31 populations of 19 species of marine mammals and sea turtles in the U.S. that had been granted endangered species protections and found that around three-quarters of them had increased in size.

"The Endangered Species Act not only saved whales, sea turtles, sea otters, and manatees from extinction, it dramatically increased their population numbers, putting them solidly on the road to full recovery," Center for Biological Diversity scientist and study coauthor Shaye Wolf said in a press release. "We should celebrate the Act's track record of reducing harms from water pollution, overfishing, beach habitat destruction, and killing. Humans often destroy marine ecosystems, but our study shows that with strong laws and careful stewardship, we can also restore them, causing wildlife numbers to surge."

In total, 77 percent of the populations







studied increased, six percent declined and 16 percent did not follow an observable trend. Seventy-eight percent of marine mammal populations increased while nine percent, representing two species, decreased. Seventy-five percent of sea turtle populations rose, and none of the turtle



populations studied declined ...

The 24 species studied that had recovered most successfully were all listed 20 years ago or more, suggesting that it does take time to help a population recover ... The study comes at a crucial time for the Endangered

### Fair Use Law: https://copyright.gov/fair-use/more-info.html

Fair use is a legal doctrine that promotes freedom of expression by permitting the unlicensed use of copyright-protected works in certain circumstances. Section 107 of the Copyright Act provides the statutory framework for determining whether something is a fair use and identifies certain types of uses such as criticism, comment, news reporting, teaching, scholarship, and research—as examples of activities that may qualify as fair use. Section 107 calls for consideration of the following four factors in evaluating a question of fair use:

(1) Purpose and character of the use, including whether the use is of a commercial nature or is for nonprofit educational purposes: Courts look at how the party claiming fair use is using the copyrighted work and are more likely to find that nonprofit educational and noncommercial uses are fair. This does not mean, however, that all nonprofit education and noncommercial uses are fair and all commercial uses are not fair; instead, courts will balance the purpose and character of the use against the other factors below. Additionally, "transformative" uses are more likely to be considered fair. Transformative uses are those that add something new, with a further purpose or different character, and do not substitute for the original use of the work.

(2) Nature of the copyrighted work: This factor analyzes the degree to which the work that was used relates to copyright's purpose of encouraging creative expression....

(3) Amount and substantiality of the portion used in relation to the copyrighted work as a whole: Under this factor, courts look at both the quantity and quality of the copyrighted material that was used. If the use includes a large portion of the copyrighted work, fair use is less likely to be found; if the use employs only a small amount of copyrighted material, fair use is more likely....

(4) Effect of the use upon the potential market for or value of the copyrighted work: Here, courts review whether, and to what extent, the unlicensed use harms the existing or future market for the copyright owner's original work. In assessing this factor, courts consider whether the use is hurting the current market for the original work (for example, by displacing sales of the original) and/or whether the use could cause substantial harm if it were to become widespread....



Species Act, however, as both Republicans in Congress and the Trump administration have made moves to weaken its protections.

"The recovery of listed species depends ultimately on the adequate implementation of the ESA's tools and other conservation measures," the study's authors wrote. "Studies have demonstrated that the government's failure to fully implement the ESA's protections and adequately fund conservation actions have been major impediments to species recovery."

On the Wild Side: Nature's Valentine

Years ago, I began exploring design in nature and pressing many flowers, mostly dissecting them for their basic components of petals, stamen, pistil, and sepal. Once pressed I used them to create designs, mandalas mostly, framing them and sometimes selling. I also pressed leaves of many shapes. Basically, I was exploring the infinite diversity of shape and form in nature, a rather mind-boggling adventure to be sure!

As I continued to explore, I discovered a petal design which most serious gardeners know; I was thrilled to see rose petals with heart shapes! Even the multiflora rose, an invasive brought over from the British Isles, has wonderfully-shaped hearts! So, I began seriously collecting and pressing hearts from them and many other rose bushes, to incorporate in my mandalas. I also discovered little bird shapes in locust and red bud flowers as well as the white and yellow sweet clovers which grow here on my property. These I sometimes added to my meadow scenes. It was my heartfelt craft.

Recently, while reading Dr. Remen's book about healing, I learned that the rose "is one of the oldest archetypical symbols for the heart...appearing in many Christian and Hindu traditions and in many fairy tales." Learning this greatly inspired me, and so for Valentine's Day I am sharing with you some of her deeper understandings, for who does not love hearts?

As children, many of us enjoyed creating special hearts for others out of red and pink paper, sometimes decorating them creatively with glitter and even with frills around the edges. Some people may still do this with heartfelt love. I find this affinity for hearts and roses very intriguing and deeply symbolic, not sappy!

Dr. Rachel Remen, besides being a compassionate spiritual therapist for people in their last days of cancer, has also had an illness of her own, which she has lived with all her life: Crones disease. In her short

essays she sprinkles stories of her own suffering in small doses, but mostly focuses on the stories of others.

One of Dr. Remen's clients, being treated for ovarian cancer, said that she had no heart, but that her amazing success in business was a direct result of her ruthlessness. As her therapy continued, she began to speak of her traumatic time as a young child during the Vietnam war and how she saw her family ruthlessly killed. She became homeless, was brutalized herself, even killed others to survive, and was filled with hate. She proclaimed herself to be a bad person, selfish, and unloving, with nothing but darkness in herself, and she was despairing because of this.

Just as she thought she might die in despair from her cancer and the lack of love in her heart, with no resolution, she had a dream about a beautiful rose, its color an exquisite shade of pink. Weeping, she said, "It is still there. All this time it is still there. It has waited for me to come back for it."

This was a part of herself she had kept safe, hidden even from herself, said Dr. Remen. Perhaps this was even a rose in the garden she remembers from her life before the war blew it apart. The rose was symbolic of a part of her that had never been touched, pure and unscathed by terror.

All of us have that rose with heartshaped petals in our lives, be it in our gardens or in our own hearts. The Earth itself is filled with wonderful healing flowers and, in fact, is the heart of our hearts. Without Earth's purity we will die from fear, distress, and abuse; and we will take the Earth with us, unless we recover our hearts.

Personally, I have had a love affair with the natural world since I was a little girl and feel profoundly blessed to have sur-

extinct every day. Countries are not meeting their own targets to protect nature and we are losing biodiversity at an unprecedented rate. Population growth, urbanization, rampant industrialization, and climate change are all now threatening the fundamentals of life itself.

**The Heat is On:** The last four years – 2015, 2016, 2017, and 2018 – are the top four hot-test years ever recorded. And in fact, 20 of the last 22 years were the warmest on record.

Antarctica: A new study just released shows that Antarctica ice is melting six times faster than in the 1980s. Since 2009, the ice lost in Antarctica has been 252 billion metric tons per year compared to 40 billion metric tons in the1980s.

**The Arctic:** The rate of sea ice decline for December is a startling 47,200 square kilometers (18,200 square miles) per year -3.7 percent per decade relative to the 1981 to 2010 average. A wide expanse of ice about twice the size of Texas has melted away during the last three decades.

**Greenland:** A new study published today in *Proceedings of the National Academy of Sciences* shows that Greenland is melting four times faster than it did just 15 years ago. This has "frightening implications for the pace and extent of future sea level rise," as reported in EcoWatch. "We're going to see faster and faster sea level rise for the foreseeable future," according to Ohio State University geodynamics professor Dr. Michael Bevis. "Once you hit that tipping point, the only question is: How severe does it get?"

**Oceans Are in Serious Danger:** Oceans contain over 96% of the Earth's water and cover over 70% of the planet's surface. The importance of healthy oceans cannot be overestimated. A recent study reveals that the world's oceans are warming 40% faster than previously thought. "Our waterworld is in serious danger...things really are as bad as we feared," writes Eric Holthaus in a *Grist* article.

We're adding the equivaltent of four Hiroshima bombs of heat energy every second to the oceans. In 2018, the oceans gained about nine zettajoules of heat energy. (For reference, annual energy use for all human civilization is about 0.5 zettajoules.)

An October 2018 study featured in *Nature* shows three alarming facts:

**1**. The oceans have absorbed 93% of all the heat we have added to the atmosphere;

**2.** Planetary warming is much more advanced than previously estimated; and,

**3.** The sensitivity of Earth's systems to greenhouse gases is much higher than previously thought.

"We can't undo this," says Harold Wanless from the University of Miami's Geological Science.

### **Emissions on the Rise Again**

I was born at a CO2 concentration of 310.4 ppm (1947). The current concentration of CO2 now exceeds 410 ppm and continues to rise. The UN's 2018 Emissions Gap Report shows that the world is so off track that greenhouse gas emissions will need to drop by 55% for the world to achieve the 1.5C aspirational goal of the Paris Agreement. In other words, the goal is pure fantasy.

In fact greenhouse gas emissions are on the rise again, In 2017, global CO2 emissions rose by 1.2% to an all-time high of 53.5 billion tons per year. In the U.S., CO2 emissions in 2018 rose by approximately 3.4% after several years of decline.

"At precisely the time in which the world must begin rapidly decarbonizing to avoid runaway climate disaster, the United States is moving further and faster than any other country to expand oil and gas extraction," reports *Oil Change International* in its latest analysis. The United States is, "Gearing up to unleash the largest burst of new carbon emissions in the world between now and 2050," with an oil and gas expansion equivalent to nearly 1,000 coal-fired power plants."

The U.S. oil and gas expansion will "impede the rest of the world's ability to manage a climate-safe, equitable decline of oil and gas production," claims the report.

#### Political Will Is Weakening

The political will required to coalesce world leadership into a body laser-focused on shifting the world economy off fossil fuels is simply non-existent. "While it's technically possible, it's extremely improbable, absent a real sea change in the way we evaluate risk... We are nowhere near that," claims Drew Shindell, a Duke University climate scientist and a co-author of the IPCC report.

For the most part, world leaders are only paying lip service to the global climate challenge. World climate leadership is fraught with hypocrisy, misinformation, double standards, and political grandstanding. And even the more progressive world leaders fall far short of what is needed to solve the climate crisis.

"Could the world be sleepwalking into a crisis?" asks Aengus Collins, Head of Global Risks of the World Economic Forum. "In a world of shifting power and divergent values, it is likely to become more difficult to make progress on shared global challenges" such as climate change. In its annual risks survey, the environment now dominates the top 10 risks. The failure of climate-change mitigation and adaptation, and extreme weather are the top two risks.

#### It's a Real Crisis

If we were serious about the climate crisis, it should be constantly on our mind. Climate should be on the news every day. It should be discussed on street corners, around the water cooler, at the dinner table, in the classroom, on radio talk shows, on nightly news, with your Uber driver... It should be on everybody's lips. We should be talking about it regularly. But we don't.

For most of the 7.7 billion inhabitants of the planet, climate change remains a secondary and remote concern relegated to the back of the mind. Daily survival is the driving force.

We will never solve the climate crisis until we treat it as a real crisis, until we start acting as if we are in a crisis. In the words of Greta Thunberg, "Everyone keeps saying that climate change is an existential threat and the most important issue of all and yet they just carry on like before. I don't understand that, because if the emissions have to stop, then we must stop the emissions. To me that is black or white. "There is no grey area when it comes to survival. Either we go on as a civilization or we don't. We have to change. We have to change."

With such a grim prognosis for humanity, I often wonder how I can continue to devote myself to my climate activism. The feeling of loss is heartbreaking. Or maybe it's because of it that I cannot stop.

I am Counting every blessing The Almighty has done for me. I dedicate this award to all those who have been told it's not possible, but you continued to believe that it is indeed possible.

One of the many paths to success was revealed to me after a chance meeting with a great friend called Anthony Ford-Shubrook. He made me realize that nice ideas and concepts have their roots in the passionate desire to dress a need that threatens survival or convenience.

He explained further that one still needs a get a Team (people who believe in your sincere desire to make things right or Mentor, those that inspire you to get the right things done) and he told me that with this remarkable impact, success is inevitable.

I was inspired after meeting this young man who has become a great friend of mine. I went back home and discovered another factor that covers it all – a positive "Environment."

So, to add them all up, try to conceptualize your Idea, make sure it relates and responds to the challenge at hand, then bring in your Team as I defined above and a factor that's so important – a positive, nontoxic environment (geographical space where the success will be manifest). All together the recipe with that formula is undeniable Success and an impactful life.

That's where the story of Anthony comes in, and I will share.

After being denied access into a college in the UK due to his wheelchair, he felt sad and decided to do something about it (growth mindset). Anthony took the institution to a UK court. Some people try to discourage a 17-year-old lad who was determined to work out his destiny not minding his predicament. He mustered up an extraordinary plan with a great legal team who believed in his vision. He won and made legal history in the UK.

But our man didn't stop at that; he started advocating for others with any form of disability. He told me that this vulnerable group were citizens that fate dealt a bad hand to, but because they are alive, hope has a fighting chance to live out their lives with dignity.

He revealed that his work paved the way for the Special Education Needs and Disability Act, currently law in UK and some parts of the EU nations.

Anthony had brought to the consciousness of government that creates space or

platform to listen fairly to concerns that impede on the survival or progress of others. What I call a positive national Environment.

After winning the court case against him he realized that millions in the UK were not as fortunate and millions more coming behind may not be lucky. He told me that about 10% of the global population, i.e about 650 million people, use a Wheelchair or will need assistance from it and they truly need it to become productive or to get by in their environment.

So he knew that getting "ACCESS" to these often-forgotten people was key; hence, he developed his entire life to establishing strategies and concepts that provide Access to those affected in his country and now across the globe. Millions of lives have been blessed by this now 32-years-old man, who was in 2016 selected as one of 17 UN Young Ambassadors to drive the global vision we call SDGs (Sustainable Development Goals).

Anthony currently was awarded the prestigious Order of the British Empire award and is still raising awareness of the inequalities and discrimination faced by the physically challenged people across the world working with a wonderful team at the AbleChildAfrica.org.

The points of this Story, I shared to you are as follows:

L. Never back down when there seem to be insurmountable challenges; don't turn your back because it may be convenient for you. It may cost millions or billions of other people much more than turn their back.

2. Once one is able to recognize a challenge, any and all challenges, you must be able to fully relate with it. Reach out to your Team/mentors in that area to find out what is likely the way out (solutions); take note your Team are like-minded people or mentors.

Final point, the environmental factor to me is the most important maybe because of the region where I come from (Nigeria). Many young Nigerians (and by extension Africans) don't have a positive environment or platform to plead their cases. And you all know progress they come from environments/Nations that are toxic, or environmentally unstable. So, there won't be venues to seek redress or petition and this to me may be one of the failures of the current class of leaders in Africa and some repressive climes.

The lack of platforms, and in some cases complete destruction of existing dysfunctional platforms, leads to the endless conflict all over the Africa continent and in a few other continents.



### After 20 Years, Assam Government Declares Deopahar as Reserve Forest

GUWAHATI, India: After 20 years, the state government has finally notified the 133.45-hectare (330 acres) area of Deopahar in Golaghat district as reserve forest. Deopahar was at the centre of a legal battle over Numaligarh Refinery Limited's (NRL) boundary wall and proposed township.

The notification came after the Supreme Court, on January 18, dismissed NRL's petition in the apex court against National Green Tribunal (NGT)'s 2016 order to demolish the boundary wall that came up on the then proposed reserved forest, blocking the movement of elephants.

The government's notification of January

19, which was made public recently, said in the exercise of powers conferred by Section 17 of the Assam Forest Regulation 1891, the governor is pleased to declare Deopahar as a reserve forest. The issue was pending since 1999.

Environment activist and petitioner of the case in the NGT, Rohit Choudhury, said the declaration of reserve forest has at last given legal recognition to Deopahar. "After two decades of waiting, the government declared Deopahar as a reserve forest following NGT and Supreme Court's intervention in the case related to NRL's boundary wall. This is a victory for conservation," added Choudhury.

In 2016, the NGT had ordered demolition of the wall that came up in the area in 2011 as it is part of Deopahar and also falls in the "no development zone" issued by the Union ministry of environment and forest in 1996. The 2016 order also said that NRL's proposed township also falls in Deopahar. NGT had given one month's time for demolition of the wall and ordered that the proposed township should not come up in the present location. Last year, dismissing NRL's review application of 2016 order, the NGT said, "In view of categorical findings already recorded by the tribunal that the area where the wall came up and the area where the proposed township is to come up is part of the Deopahar Reserve Forest, rehearing on merits is not permissible."

In January 18 this year, the Supreme Court also dismissed NRL's review petition.

### History from the 2014 Constitution of Jinja Church Children's Home and Orphanage (JICCHO)

#### **ARTICLE TWO: BACKGROUND**

The organization was started after the realization of communities being faced with a big challenge of orphans and vulnerable children who are not accessing formal education and living in appalling situations, due to HIV/AIDS scourge and would like to access formal education and we together believe that the most viable way to liberate the orphans and vulnerable children (OVC), street children, youths of Africa is to directly invest in their formal education for this will widen their horizons and opportunities, support the youth engage in income-generating activities, and mobilizing the children from streets back home and camps.

# In Developing Countries, Climate Change is Destroying Our Communities First

Growing up without running water in Kabanana Compound, Beatrice Phiri discusses how she got to see first-hand the dramatic effects of climate change.

Much of my life has revolved around the pursuit of water. Living in my community was challenging because we all endured the difficult task of fetching water. For most families, this was the responsibility of the girls and women. So, from the age of 15, it was my duty to ensure my family had enough water for the day.

I had to wake up as early as 4 a.m. and walk 20 minutes for this task. My family and I had to use as little water as possible so that we would save most of it for drinking and cooking. I was usually exhausted by the time I made it to class, which began at 7 a.m.

Fetching water always made me nervous because of the possibility of getting attacked or defiled on the way. Another hard reality was that I often fought with other girls and women, and sometimes even the boys and men, to ensure that I had a share of water for my family. Global climate change exacerbated this great challenge of fetching water in my community. During the 2015-16 rainfall season, Zambia faced a huge problem — little to no rain in most parts of the country. This was also a time when temperatures worldwide continued to soar. In 2016, each of the first six months of the year set the record for the warmest month in modern temperature records, which date back to 1880.

In Kabanana Compound, climate change caused our lakes to dry up meaning that most homes did not have water. And some days, we did not have electricity. As the situation continued to worsen, some parts of the community even became affected with cholera due to lack of proper water and sanitation. This made members of my community completely helpless.

Luckily, some heavy rains during the beginning of 2017 helped stabilize the situation. But it proved that climate change can be very unpredictable and can also be devastating to the most vulnerable.

Our actions have led us to a huge disaster. Mankind's continuous oblivion and contribution to global warming will make life catastrophically difficult for billions of people around the world.

Somewhere in a developing country there is a girl or boy experiencing the same challenges I have, some in a much worse situation. They lack a voice because those with power remain silent on the environmental issues that take away basic rights to survival.

They lack education on climate change because government, the private sector, NGOs, civil society organizations, and many others haven't given them opportunities to learn. They lack solutions because even though most people know we should be addressing climate change, our societies haven't taken serious efforts and action.

Climate change is an issue that needs every human's attention. For many people, it's just a buzzword, climate change hasn't made an impact on their lives. Yet. But imagine what this world would look like if we continue ignoring climate change: more dry rivers and lakes, more fires, more polluted air, diminishing resources, and no sustainable energy to turn to. Communities will wither, but for those of us in developing countries, it has already begun.

### 16-Year-Old Greta Thunberg's Demand to Davos Elite: Act Urgently on Climate for `Sake of This Beautiful Living Planet"

Sixteen-year-old climate activist Greta Thunberg threw down the gauntlet to the global elite gathered in the Swiss Alps for the World Economic Forum (WEF) this week, urging them to work towards meaningful climate action in order to "safeguard the future living conditions for humankind."

"Some people say that the climate crisis is something that we all have created. But that is just another convenient lie," the Swedish teen says in a video posted to Twitter. The video was also posted on the WEF Facebook page and was intended to be shown to the attendees inside.

In fact, there is blame to be assigned, she says, namely to "some companies and decision makers" who have "known exactly what priceless values they are sacrificing."

She calls on those powerful interests to set aside their drive for massive economic profits and instead "safeguard the future living conditions for humankind" by committing to "real and bold climate action."

She expresses skepticism that that will happen, but said she hopes she's proven wrong "for the sake of your children, for the sake of your grandchildren, for the sake of life and this beautiful living planet." Doing so would allow them to "stand on the right side of history," she adds.

Thunberg posted the video a day ahead of her arrival – by train – in Davos, where she'll take part in a panel discussion. Meanwhile, her joint op-ed with former United Nations climate chief Christiana Figueres declared it "outrageous" that the climate crisis is not taking center stage at the WEF gathering. Published Wednesday at the *Washington Post*, the pair, "united by the same concern for our planet," argue that it "should be the number one priority."

There is plenty to lament – rising CO2 emissions, new coal burning power plants, and deadly air pollution. We are "quickly approaching tipping points of no return," they write. At the same time, they believe "these are inspirational times for transformational change," noting the historic Paris climate accord and global "school strike for climate," which Thunberg catalyzed. Students around the world taking a stand for urgent climate action, they write, have declared that "they are unstoppable and that another world is possible."

But to even begin taking a crack at the urgent crisis, they lay out a three-step "find

and replace" exercise for Davos attendees:

**1**. Find coal, and replace it with renewable energy supported by storage.

**2.** Find internal combustion engines, and replace them with zero-emissions mobility.

S. Find crop burning (when farmers burn the stubble left over from the harvest to clear the ground quickly for new planting) and replace it with "no till" and "low till" technologies that enrich the soil instead of burning its nutrients. "We are going to do everything we can to put an end to dirty fuels and dirty air so we can improve the prospects of people everywhere," they conclude.

Though she will still be in Switzerland on Friday, Thunberg has no plans to put a pause on her Friday strikes:

# Restless Youth Seek Climate Action

Young people around the world are increasingly restless over the lack of foresight and urgency to address the threat of climate change. The youth have always embraced environmental activism, demanding action from world leaders from time to time.

From the 1992 Earth Summit at Rio de Janeiro to the UNFCCC COP 24 at Katowice in December last year, young people have sought to galvanize the climate movement. The voices of discontent have grown in the past few months and youth are now crowding the streets around the world to demand immediate action on climate change. A few days back, over 12,000 students walked out of their classrooms in Belgium to join the country's second youth-led climate march in a week, demanding bold action from European leaders on the global climate crisis.

For then-15-year-old Greta Thunberg, the girl who started the 'school strike for the climate' movement in August 2018, it all started with a silent protest in front of the Swedish parliament. Initially she was alone, and few took notice of the teenage protester on the pavement. When people did start to pay attention, she let them know that she would

skip school until the government acted on climate change. She handed out leaflets accusing the adults of jeopardizing her future. And the environmental movement had a new star. Greta's strike has inspired tens of thousands of students in over 270 cities around the world, spawning movements like 'School Strikes 4 Climate' and 'Fridays for Future'.

Back in 1992, it was a 12-year-old Severn Cullis-Suzuki who silenced the world for six minutes at the first UN Earth Summit at Rio de Janeiro. Twenty-five years later, young people across the globe are still fighting to save the planet. Wary of the repeated failure of adults to take decisive action on climate change, enterprising youth-led organizations have created successful models for a sustainable future. Others have used the law; a slew of legal actions in recent years has opened up the debate on the accountability of the present global leadership towards the future generations.

In 2002, 21-year-old Billy Parish dropped out of Yale University to help found the Energy Action Coalition, eventually renamed the Powershift Network. It became the largest youth-led clean energy advocacy network in the world, bringing together 50 environmental and social justice groups and over 340,000 members. The Energy Action Coalition motivated over 600 colleges to make commitments to climate neutrality and trained tens of thousands of young people. In March 2009, the Energy Action Coalition organized Power Shift '09, which brought over 12,000 young people to Washington, DC, which was then the largest climate-focused training, lobby day, and non-violent civil disobedience action in U.S. history.

In 2007, Plant-for-the-Planet, an initiative to raise awareness amongst children and adults about climate change and global justice, was founded by a nine-year-old German boy, Felix Finkbeiner. Plant-forthe-Planet considers tree planting to be a practical and symbolic action in efforts to reduce the effect of climate change and has since grown into a global movement reaching its initial goal of planting a million trees in just four years.

The youth are actively engaged at local, national, and global levels in raising awareness, running educational programs, conserving nature, promoting renewables, and inspiring personal commitments to environment-friendly lifestyles. In the year 2009, in response to the growing number of youth organizations engaged in the intergovernmental climate change process, the UNFCCC secretariat had extended constituency status to admitted youth NGOs, al-

lowing them to receive official information, participate in meetings, request speaking slots, and receive logistical support at UN-FCCC conferences.

In the U.S., 21 young plaintiffs between 9 and 20 years old, led by the environmental law nonprofit Our Children's Trust, together with climate scientist Dr. James Hansen, filed that famous lawsuit in 2015. They accused the federal government of violating the younger generations' constitutional rights to life and liberty by declining to take action against global warming. The lawsuit is still going on, while the plaintiffs have become role models for youth around the world. However, they were not the first to file a case regarding government inaction on climate change. In 2011, 17-year-old Alec Loorz, who was inspired by An Inconvenient Truth, had sued the federal government for (in)action on global warming.

Last year, Ridhima Pandey, a nine-yearold in India filed a petition with the National Green Tribunal against the Indian government for not complying with the Paris Agreement on climate change. She urged the government to take measured and concrete steps toward reducing the country's carbon footprint and to focus on reforestation.

In Pakistan, a young farmer, Asghar Leghari, who is also a law student, filed a petition with the Lahore High Court accusing the government of failing to act on its 2012 National Climate Change Policy. He was prompted by repeated crop failures due to water scarcity and temperature shifts but clarified that he was not seeking compensation for crop losses but sought broader action against future consequences.

In the Netherlands, young activists were jubilant when the Dutch court ordered the state to reduce emissions by 25% within five years to protect its citizens from climate change in the world's first climate liability suit.

Inspired by these events, a law student in New Zealand, Sarah Lorraine Thomson, challenged the Government in the High Court over its failure to properly address climate change and unambitious targets on reduction of emissions.

These successes have added to the motivation of younger generations to demand action for safeguarding their future.

The Intergovernmental Panel on Climate Change (IPCC) 1.5 C report last year made it clear that limiting catastrophic warming beyond 1.5 C above the pre-industrialization levels would require "rapid, far-reaching, and unprecedented changes" in all aspects of society. The landmark report painted a dire picture of the immediate consequences of climate change and gave us a little over a decade for decisive action.

World leaders at COP24, following the publication of the IPCC report were expected to show some urgency and rise to the challenges. The compromise at Katowice has fueled the restlessness of youth, who correctly see climate change as an existential threat to life on Earth.

While addressing the negotiators at COP24, Greta reflected the anxiety of the youth on the slow progress of climate talks in the past. "For 25 years, countless people have come to the U.N. climate conferences begging our world leaders to stop emissions, and clearly that has not worked as emissions are continuing to rise. So, I will not beg the world leaders to care for our future. I will instead let them know change is coming whether they like it or not."

Today's youth are the first generation to feel the impacts of climate change and possibly the last that can do something about it. Half the world's population is now under 30 years old, and those youth are becoming increasingly powerful political and social advocates for action on climate change. The new generations have the energy and knowledge to lead our societies towards a low-carbon and climate-resilient future. There is no doubt that it is the youth of the world who have it in them to save us from catastrophic climate change, but do we have enough time?

Perhaps it is this very thought, driven home by the IPCC 1.5 C report from last year, that makes the youth restless in the first place.



J pointed to the hook. "How will it get there?"


He said he'd pretend that the jacket can walk and will walk it to the hook.






Photo: The EAT-Lancet Commission In a new report about human health and the environment, experts call for people across the globe to follow a "flexitarian" or "planetary health" diet.

### Scientists Call for 'Global Agricultural Revolution' and 'Planetary Health Diet' to Save Lives and Earth

While scientists continue to call for immediately phasing out fossil fuels across the global to avert climate catastrophe, a team of international experts on Thursday unveiled a proposal to address another major driver of the climate crisis: the world's unhealthy and unsustainable food system.

"The food we eat and how we produce it determines the health of people and the planet, and we are currently getting this seriously wrong," declared Tim Lang, a co-author of the EAT-Lancet Commission and professor at City University of London. "We need a significant overhaul, changing the global food system on a scale not seen before in ways appropriate to each country's circumstances."

The commission brought together 37 experts in agriculture, environmental sus-

tainability, human health, and political science from 16 countries. Over three years, they developed the "Planetary Health Diet," which aims to address the global food system's devastating environmental impact as well as mass malnutrition.

Noting that more than 800 million people worldwide "have insufficient food, while many more consume an unhealthy diet that contributes to premature death and disease," co-lead commissioner Dr. Walter Willett of Harvard University said the "world's diets must change dramatically" to reverse the damage that's been done. "To be healthy," he explained, "diets must have an appropriate calorie intake and consist of a variety of plant-based foods, low amounts of animalbased foods, unsaturated rather than saturated fats, and few refined grains, highly processed foods, and added sugars."

"This is the first attempt to set universal scientific targets for the food system that apply to all people and the planet," according to the final report, Food in the Anthropocene: Healthy Diets From Sustainable Food Systems, found at https://eatforum.org/content/uploads/2019/01/EAT-Lancet\_Commission\_Summary\_Report.pdf.

The "Great Food Transformation" envisioned by the commission acknowledges that the world population is on track to reach an estimated 10 billion by 2050. The researchers considered current food production and consumption trends in terms of not only planet-warming emissions but also cropland and freshwater use, nitrogen and phosphorus cycling, and species extinction.

"Humanity now poses a threat to the stability of the planet," co-lead commissioner Johan Rockström of the Stockholm Resilience Center told *The Guardian*. "[This requires] nothing less than a new global agricultural revolution."

The report, published in *The Lancet*, lays out five key strategies for its proposed overhaul of global food norms:

**1**. Seek international and national commitment to shift toward healthy diets that feature more plant-based foods – including fruits, vegetables, nuts, seeds, and whole grains – and less animal products.

**2.** Reorient agricultural priorities from producing high quantities of food to producing healthy food that nurtures human health and supports environmental sustainability.

**S** Sustainably intensify food production to increase high-quality output with a series of reforms that include becoming a net carbon sink from 2040 forward to align with

### Opinion: Sooner or Later, We Have to Stop Economic Growth - And We'll Be Better Off for It

Both the U.S. economy and the global economy have expanded dramatically in the past century, as have life expectancies and material progress. Economists raised in this period of plenty assume that growth is good, necessary even, and should continue forever and ever without end, amen. Growth delivers jobs, returns on investment, and higher tax revenues. What's not to like? We've gotten so accustomed to growth that governments, corporations and banks now depend on it. It's no exaggeration to say that we're collectively addicted to growth.

The trouble is, a bigger economy uses more stuff than a smaller one, and we happen to live on a finite planet. So, an end to growth is inevitable. Ending growth is also desirable if we want to leave some stuff (minerals, forests, biodiversity, and a stable climate) for our kids and their kids. Further, if growth is meant to have anything to do with increasing quality of life, there is plenty of evidence to suggest it has passed the point of diminishing returns: Even though the U.S. economy is 5.5 times bigger now than it was in 1960 (in terms of real GDP), America is losing ground on its happiness index.

So how do we stop growth without making life miserable – and maybe even making it better?

To start with, there are two strategies that many people already agree on. We should substitute good consumption for bad, for example using renewable energy instead of fossil fuels. And we should use stuff more efficiently – making products that last longer and then repairing and recycling them instead of tossing them in a landfill. The reason these strategies are uncontroversial

the goals of the Paris climate agreement.

4. Strong and coordinated governance of land and oceans, including by implementing a "Half Earth" strategy for biodiversity conservation.

**5.** At least halve food losses and waste, in line with the U.N. Sustainable Development Goals (SDGs), on both the production side and the consumption side.

Alongside its report, the commission put out a brief (https://eatforum.org/content/ uploads/2019/01/EAT\_brief\_everyone.pdf) identifying top takeaways and specific actions that individuals can take to help trans-

is that they reduce growth's environmental damage without impinging on growth itself.

But renewable energy technology still requires materials (aluminum, glass, silicon, and copper for solar panels; concrete, steel, copper, and neodymium for wind turbines). And efficiency has limits. For example, we can reduce the time required to send a message to nearly zero, but from then on improvements are infinitesimal. In other words, substitution and efficiency are good, but they're not sufficient. Even if we somehow arrive at a near-virtual economy, if it is growing we'll still use more stuff, and the result will be pollution and resource depletion. Sooner or later, we have to do away with growth directly.

If we've built our institutions to depend on growth, doesn't that imply social pain and chaos if we go cold turkey? Perhaps. Getting off growth without a lot of needless

form the global food system. Suggestions include buying more sustainably-produced food, embracing plants as a source of protein, and slashing both meat consumption and food waste.

The unveiling of the Planetary Health Diet follows a series of recent studies that have shown it is environmentally necessary for humans – particularly in the United States and Europe – to dramatically reduce red meat consumption. The main key will be to focus on increasing equality. During economic contraction, the best way to make the situation tolerable to a majority of people will be to increase equality. From a social standpoint, equality will serve as a substitute for growth. Policies to achieve equity are already widely discussed, and include full, guaranteed employment; a guaranteed minimum income; progressive taxation; and a maximum income....

# `We're not extinct': Marchers in U.S. Call for Indigenous Rights

WASHINGTON, DC – Indigenous people from across the globe gathered in the U.S. capital on Friday for a march drawing attention to social and environmental injustices against indigenous communities worldwide, in what organizers said was a first-ever event.

Coordinators said more than 1,000 participated in the Indigenous Peoples March, aimed at raising awareness about systemic problems, including police brutality, violence against women, voter suppression, and an "environmental holocaust."

Up to 2.5 billion people depend on indigenous and community lands, which make up more than half of all land globally, but they legally own just 10 percent. Campaigners say native groups are struggling with encroachment by governments and logging, mining, and agribusiness companies. "We're here in support of the aims of indigenous peoples across the world – that is, for our safety, health, the protection of our families and our water, for the protection of our lives," said Rufus Kelly, of the Nottoway Tribe in Virginia. "And we want to make sure that people know we have not gone anywhere – that we are still here. We're not extinct. We're right here among you, and we want to share that with you."

Parallel events took place in other U.S. cities and abroad, said Jesse Phelps of the Lakota People's Law Project, saying the D.C. march was a "huge step toward the unification and amplification" of indigenous voices.

The march stems from a months-long, 2016-17 protest between the U.S. government and the Standing Rock Sioux Tribe over plans for an oil pipeline to cross Sioux lands in North Dakota, said co-organizer Nathalie Farfan, noting that one of Donald Trump's first moves as president was to approve construction on the project. "Standing Rock was a traumatic situation, but that was also the first time we saw allies come from all over to help out," Farfan said.

That type of solidarity-building has been taking place across the globe, according to Victoria Tauli-Corpuz, the United Nations' top expert on the rights of indigenous peoples, who said she "fully supports" Friday's marches.

"Indigenous peoples in almost all parts of the world are still suffering from racism and discrimination and gross violations of their human rights, but their persistence in strengthening their movements and communities enabled some of them to succeed in protecting their lands and territories from environmental destruction," she told the Thomson Reuters Foundation.

While TransCanada scrambles, unity among Tribal Nations, farmers, ranchers, young people, and climate advocates against Keystone is growing. # Victory! Logging Giant's Lawsuit Dismissed: CEOs: Be Warned, Do Not Sue Activists

U.S. federal court dismisses free speech lawsuit in full against Stand.earth; drops all racketeering claims. Resolute Forest Products loses controversial case against Stand.earth; nearly all Greenpeace claims dismissed, including racketeering charges.

Dear Iona,

We just won a \*huge\* legal victory over corporate bullying and intimidation.

Minutes ago, a U.S. Federal judge threw out Resolute Forest Products' \$300 million federal lawsuit against Stand.earth, and threw out the vast majority of the same suit targeting our friends at Greenpeace.

We were targeted because we spoke out against unsustainable logging practices. Our dogged and unrelenting advocacy to protect precious old growth Boreal forest was creating real, transformative change throughout the logging industry, so Resolute launched a \$300 million intimidation lawsuit to try and shut down our work. The Canadian logging giant has spent millions of dollars trying to bully us out of existence with this mega lawsuit – and today it lost definitively.

After being dragged through court for

more than two years, the most dangerous part of this legal saga is finally over for Stand. But what Resolute started has taken on a life of its own, so we need to step up and stop copycat lawsuits before this becomes a trend.

Resolute's lawyers were hoping to use this legal decision to kick-start a wave of terrifying intimidation lawsuits designed for one thing only – to stop citizens from speaking out and cripple the effectiveness of advocacy organizations like Stand. Oil giants like Energy Transfer Partners (the company behind the Dakota Access Pipeline) have already launched similar lawsuits against activists and organizers, and we know that other CEOs have their own lawsuits lined up, ready to file.

We have to show these CEOs that frivolous bullying lawsuits are a waste of time. Over the coming weeks and months, we intend to speak out in the media and at industry events, making sure that every single Fortune 500 company knows about Resolute's losing attack on free speech, so other companies don't follow this terrible example.

We'll also be asking many of Resolute's customers – book publishers, newspapers, and magazines – how they reconcile spending millions buying paper from a company that's attacking freedom of expression, one of their core values.

Attacks on advocacy organizations like Stand are on the rise globally, as giant corporations try every trick in the book to quash our work. These lawsuits are one of their dirtiest tactics – putting a cost on speaking out, in a desperate attempt to stop people from taking action on the issues that matter most.

Enough is enough. We need to stand together with others who are also facing legal intimidation for standing up for basic rights and human dignity. We need to stop this dirty tactic for good. By standing up for each other, we'll send a clear message: Not only are these lawsuits a waste of time, they actually make our movement stronger.

Over the next few months, we plan to speak up loudly and connect with as many CEOs as possible to make sure they know that these intimidation lawsuits are a waste of time.

While we triumphed over Resolute – and, in fact, the corporate bullying only made us stronger and more determined to run and win important campaigns – the threat is far from over.

I hope you'll join us in this effort. Because the future of a vibrant civil society, and our right to free speech, depends on it.
